GlobalMET is the only Global Association which is managed and run by the MET providers themselves.

In December 2002, GlobalMET was incorporated in Australia as AMETIAP (Global) Ltd.

"The name Global Maritime Education and Training Association", with the working name "GlobalMET" and a new logo, were adopted in 2006, to reflect the growing global role with more members based outside the Asia Pacific region."

In February 2007, the registered name in Australia was changed to 'GlobalMET Limited'.

In the year 2008, GlobalMET achieved the NGO status at IMO and a representative attends IMO Committee meetings dealing with maritime education and training.

Today, GlobalMET enjoys membership of members across 22 economies globally including India.

#### Aims and Objectives

The establishment of GlobalMET arose from the participants' desire to support the aims and objectives of IMO for 'safer ships and cleaner oceans' and recognition of:

- The vital importance of maritime education and training in fulfilling the needs of expanding trade and economic growth;
- The urgent need for collective efforts in maritime education and training to promote greater safety at sea and protection of the marine environment.

#### **GlobalMET's objectives are to:**

- Provide a forum for the exchange of views among members;
- Foster, develop and maintain close cooperation between and among members on matters relating to maritime education and training, including maritime research and development and other matters of mutual and/or collective interest;
